4. Data Collection on Our Website

Cookies

Cookies necessary for electronic communication or certain functions (e.g., shopping cart functionality) are stored based on Art. 6 (1) lit. f GDPR. The website operator has a legitimate interest in storing cookies to ensure an optimized and technically flawless service.

Server Log Files

The provider of this website automatically collects and stores information in server log files, which your browser automatically transmits to us. These include:

- Browser type and version
- Operating system used
- Referrer URL
- Host name of the accessing computer

- Time of the server request
- IP address

This data is not merged with other data sources. The legal basis for processing is Art. 6 (1) lit. b GDPR, which allows data processing for the fulfillment of a contract or pre-contractual measures.

The data entered in the contact form is processed exclusively based on your consent (Art. 6 (1) lit. a GDPR). You can withdraw this consent at any time by emailing us.

5. Plugins and Third-Party Services

Integration of Vimeo Plugins
